Will Addis rescind plans for a 600 megawatt lithium-ion battery storage facility?

Earlier this week, Addis called on Vistra Energy to rescind its plan for a 600 megawatt lithium-ion battery energy storage facility at Morro Bay, located at the decommissioned Morro Bay Power Plant. The Texas-based energy company has owned the facility since 2017.

Will California remove battery energy storage facilities from opt-in certification?

"It will remove battery energy storage facilities from California Energy Commission's opt-in certification program, which will return the authority to decide whether to allow these facilities back where it belongs, back into the hands of local communities," Addis said.






