Overview

Should energy storage tariffs be cost-reflective?

as set by the Electricity Market Regulation. As per art. 18 of the Regulation, tariffs should be cost-reflective and not discriminate against energy storage – quite often, storage operators face disproportionate network fees that don't take into account the benefit brought by energy stor.

What is the energy storage project in Belgium?

The main energy storage project in Belgium is the construction and operation of an offshore "energy atoll" (essentially a manmade offshore pumped-storage facility), for which the Electricity Act has been modified in 2014 (see below), in order to support offshore wind-generated electricity production.

How much storage capacity does Belgium need in 2020?

The need for storage capacity in Belgium is expected to increase from 7 GW to 12 GW in 2020.

What funding is available for R&I projects in Belgium?

Belgium: Energy Transition Fund. Support for R&I projects for energy. In this context, several publicly funded R&I projects which also include storage, are being performed by Belgian research centres. The funding for energy related R&I projects in 2022 amounts to 25 million €.


