Overview

How long is the building control process in the Cook Islands?

The Building Control process is allowed 21 days. Building in the Cook Islands is legislated for by the Building Control and Standards Act 1991, the Building Control and Standards Regulations 1991 and the Building Code 2019. A new Bill and regulations are in development and we expect to see them enacted by 2026.

What regulatory functions does infrastructure Cook Islands have?

Infrastructure Cook Islands has a few regulatory functions. These are as road manager, and housing Building Control and the Electrical Inspectorate.

What is the Cook Islands building code (CIBC)?

This Cook Islands Building Code (CIBC) applies to all buildings in the Cook Islands and is empowered by its enabling legislation.

How do I get a building permit in Cook Islands?

Both the Cook Islands Building Code and the Cook Islands Building Manual are available via the Infrastructure Cook Islands' website. A Building Consent or permit is required for all new buildings and significant (as determined by the Building Controller) alterations to existing ones.

How do I build a building in Rarotonga?

For Rarotonga, the process for all building proposals starts at the National



Environment Service. If the building proposal includes a wastewater treatment system, the proposal will also require a Sewage Construction Permit from Te Marae Ora. After you have NES and TMO approvals, you then submit your building application to ICI Building Control.
