Overview

Will the US reduce tariffs on Salvadoran exports?

El Salvador's Economy Minister announced final negotiations with the U.S. to reduce tariffs on Salvadoran exports, emphasizing constructive dialogue despite uncertainties regarding a 10% tariff imposed by Trump.

How does a free trade agreement affect El Salvador?

For instance, products that are sourced from countries with which El Salvador has a free trade agreement may benefit from reduced or eliminated tariff rates, enhancing trade opportunities. Conversely, goods originating from nations without such agreements may incur higher tariffs, affecting their competitiveness in the Salvadoran market.

Does El Salvador have a bilateral trade agreement?

For countries with which El Salvador does not have a bilateral trade agreement, most of El Salvador's tariffs do not exceed the maximum standard external tariff of 15% established by the Central American Common Market (CACM) treaty, of which it is a signatory. However, there are several exceptions and agricultural products face the highest tariffs.

What are El Salvador's import and export regulations?

El Salvador has established a comprehensive set of regulations governing the import and export of goods, particularly concerning items deemed prohibited or restricted. These regulations are in place to safeguard public health, national security, and the environment, ensuring that illicit or harmful products do not enter or leave the country.

What are El Salvador's trade policies?

The history of El Salvador's trade policies reflects a commitment to liberalizing its economy. Since the 1990s, the government has implemented reforms aimed at reducing tariffs and non-tariff barriers, simplifying customs



procedures, and fostering an environment conducive to foreign direct investment (FDI).

How can exporting goods from El Salvador improve the efficiency of import operations?

Proper documentation, the role of experienced customs brokers, and knowledge of the clearance process can significantly enhance the efficiency of import operations. Exporting goods from El Salvador involves a systematic process designed to comply with national and international regulations.
