# New Energy Battery Cabinet Inspection Standards







#### **Overview**

UL Standards and Engagement introduces the first edition of UL 1487, published on February 10, 2025, as a binational standard for the United States and Canada. What are the IEEE Standards for battery maintenance & testing?

The IEEE Standards provide recommended practices and schedule for maintenance and testing, as well as guidance for determining when batteries should be replaced.

Are battery containment enclosures ul 1487 certified?

These products, through UL 1487 certification, can then provide another layer of safety for green energy. Battery containment enclosures certified by UL Solutions to UL 1487 can be found in the online certification directory, UL Product iQ®. Product iQ is available to use at no cost but requires a one-time registration.

How often should a battery be inspected?

Measure the electrolyte temperature of 10% or more of the battery cells. At least once per year, the quarterly inspection will be augmented as follows: In the case of a lead-antimony battery, measure and record specific gravity and electrolyte temperature of all cells.

What should be included in a battery test?

This should include at least: Verification of interconnected battery rack or string functionality. Auxiliary equipment testing, including standard operational lighting, emergency lighting, and HVAC or other thermal management system functionality.

Do you need a representative to test a battery?

Battery manufacturers may require that a representative be present to witness or conduct commissioning. The test should be conducted under environmental conditions included in the design specifications and deemed to



be appropriate by the battery manufacturer. The Project shall comply with WERA's Regulatory Framework and SEC's Distribution Code.

What is a battery capacity test?

A battery capacity test will consist of a controlled current discharge of the battery systems in order to determine the capacity at the rate determined by the load reserve time requirements or at the manufacturer's claimed performance rate for a specified time.
