Do I need to report a monthly photovoltaic module shipment report?

Beginning in January 2017, we required some of the respondents for the annual survey Form EIA-63B, Photovoltaic Module Shipments Report, to report monthly data. The subset of respondents now must report monthly accounts for about 90% of photovoltaic (PV) activity in the United States, based on 2021 data.

How do international trade policies shape the global solar photovoltaic landscape?

International trade policies shape the global solar photovoltaic (PV) landscape through complex networks of tariffs, regulations, and bilateral agreements that significantly impact market dynamics and industry growth.

How many dumping and import taxes are imposed on solar PV?

Since 2011, the number of antidumping, countervailing and import duties levied against parts of the solar PV supply chain has increased from just 1 import tax to 16 duties and import taxes, with 8 additional policies under consideration. Altogether, these measures cover 15% of global demand outside of China.

How has global solar PV manufacturing capacity changed over the last decade?

Global solar PV manufacturing capacity has increasingly moved from Europe, Japan and the United States to China over the last decade. China has invested



over USD 50 billion in new PV supply capacity – ten times more than Europe – and created more than 300 000 manufacturing jobs across the solar PV value chain since 2011.

Do you have to report a monthly photovoltaic account?

The subset of respondents now must report monthly accounts for about 90% of photovoltaic (PV) activity in the United States, based on 2021 data. Data collected on both the monthly and annual Form EIA-63B are protected from disclosure of individual company data. As a result of this protection, monthly data are not published in some tables.
